

WHEREAS, SATYA INSTITUTE OF TECHNOLOGY AND MANAGEMENT (SITAM) has initiated to provide competency-based employability enhancement skills for Engineering courses as approved / Recognized by appropriate Government Authority & WHEREAS BSNL Training Point in Visakhapatnam Telecom District is required to perform the role and function of providing hands-on skill training to Technical students from B. Tech. Students in ECE, CSE, IT and all its related areas and Management students from BBA / MBA WHEREAS the First Party has to nominate the number of students for the various programs offered by BSNL-TP and WHEREAS the Second Party has expressed its keen interest and desire to be a key partner in the execution of this program in terms of the objectives of the scheme and policy as highlighted and specified in the said program and particularly in view of the desire and interest of BSNL to join and partner with SATYA INSTITUTE OF TECHNOLOGY AND MANAGEMENT (SITAM) in providing competency-based skills through its training Point in Visakhapatnam.

About SITAM:

SITAM was established in the year 2011 to promote the Spirit of Technology in and around Vizianagaram. All departments are charged with the responsibility of training scientific manpower in various frontline areas of importance for the Indian nation and Global Needs. SITAM also contributes to the rapidly growing technological knowledge and professional excellence in science and technology by undertaking industrial and applied research projects. SITAM initiated programs of Vocational courses in Electrical Equipment Maintenance, Automotive Servicing, Mobile Communications, and Refrigeration Air Conditioning along with BBA, MBA, BCA, and MCA. With many feathers in its cap, such as NAAC accreditation, Permanent Affiliation from JNTUK, and IIC (Institute Innovation Cell) from the Union Ministry of Education, SITAM is soaring to new heights in the field of education and research. SITAM is determined to produce efficient and impeccable technological professionals to cater to society's technology needs and effectively shoulder the ever-changing business responsibilities at national and international levels.

Both parties have held discussions and agreed to collaborate to conduct training under this MOU and in GENERAL for Engineering Courses. BSNL will impart the requisite training and award credits for the training conducted on its own to the registered students. THEREFORE, both the parties hereby agree that the Training Point at Visakhapatnam of



BSNL, as approved and recognized by BSNL and SATYA INSTITUTE OF TECHNOLOGY AND MANAGEMENT (SITAM) from time to time, shall be known as an act / perform the role of "Training Providers" in GENERAL for Engineering Courses initiated by SATYA INSTITUTE OF TECHNOLOGY AND MANAGEMENT (SITAM) on the following terms and conditions:

- That BSNL agrees that Training Point in Visakhapatnam, set up by BSNL and hereinafter
 to be referred to as "BSNL-TP, shall act and perform the role of Training Provider to
 provide hands-on skill training in specific sectors such as Telecommunications and
 Management courses and all its related areas.
- 2. That BSNL agrees and undertakes that its "BSNL-TP" conduct skill training in specific sector such as Telecommunications and Management courses and all its related areas and shall perform the following functions:
 - a) Announce the schedule of skill training modules for the calendar year.
 - b) Register students for the modules and upload them on the BSNL website.
 - c) Conduct the skill modular training.
 - d) Conduct examination / evaluate the student, award the grade indicating completion of Training and upload the same on the BSNL website.
 - e) The BSNL-TP recognized and approved by BSNL may register students as provided by the SATYA INSTITUTE OF TECHNOLOGY AND MANAGEMENT (SITAM)
- The BSNL-TP, as specified in the Memorandum of Understanding, may take flexible training timing and schedule in consultation with SATYA INSTITUTE OF TECHNOLOGY AND MANAGEMENT (SITAM).
- 4. The BSNL-TP shall announce and inform through its website the schedule of the Skill Modules it plans to offer in the academic year concerned for the information of the prospective students, and it shall accept the students as provided by SATYA INSTITUTE OF TECHNOLOGY AND MANAGEMENT (SITAM).
- 5. The BSNL-TP shall be entitled to the fees as mentioned below.
- 6. Priority should be given to BSNL to send students for Internship, Project, and Certified courses in Engineering and Management streams during the MOU period.
- 7. Interested students shall be encouraged to take Internship, Project, and Certified courses in Engineering and Management streams during the MOU period.

- 8. The BSNL-TP will conduct appropriate training sessions as per the following pedagogy,
 - a) These various programs on different topics under this project will focus on practical hands-on training in the field/practical supplemented with structured academic content that shall be provided online and may be supplemented with appropriate theory sessions to the students of SATYA INSTITUTE OF TECHNOLOGY AND MANAGEMENT(SITAM) in Technical streams.
 - b) Practical sessions shall be held in flex mode, which shall expose the students to various Telecom equipment in terms of their operations.
 - c) Academic content shall focus on the various operational procedures/facets of the Telecom equipment/technologies present in the BSNL network related to the practical sessions in an attempt to provide the student with high-end equipment handling practical skills as opposed to rote learning.
- d) Academic Structure of Programs:
 - i) BSNL Certified Courses for Engineering Stream:

The complete spectrum of Telecom practical skill learning shall be divided into seven modules. The duration of the skill part of the program in BSNL set-ups/training Points shall be incorporated into three academic semesters of conventional engineering education B. Tech. (ECE, CSE and IT) starting with 5th semester.

- ii) INTERNSHIP / Project: The duration will be 4/6/8n weeks as per the College requirement.
- iii) Online Certificate Program (8 weeks):

This program is offered mainly on telecom-related topics:

Broadband Technology, Digital Switching Systems, Digital Transmission Systems, IP Networking and Cyber Security, Mobile Communications (2G/3G/5G), Optical Fiber Technology, and Telecom Support Infrastructure.

- iv) Seminar: One session
- v) Industrial visit: One Field visit at free of cost.
- vi) Guest Lectures: Support to deliver Guest lectures from Field experts will be delivered to the students of SATYA INSTITUTE OF TECHNOLOGY AND MANAGEMENT (SITAM) as per the affiliated University Guidelines on the Latest Technology trends and in-house requirements.



However, the new courses will be designed in accordance with the requirement/demand from the SATYA INSTITUTE OF TECHNOLOGY AND MANAGEMENT (SITAM) administration and with both parties' mutual concerns accordingly,

- f) The online content/theory sessions shall support material (soft copy) for the practical sessions in terms of descriptions and explanations obtained from our equipment manuals. Normally, it does not address theoretical concepts students learn as part of communication engineering.
- g) In addition to that, an overview of improvement of communication skills, soft skills and preparation of curriculum vita, etc., will be imparted as an additional advantage.

h) FORCE MAJEURE:

If at any time, during the continuation of this Memorandum of Understanding, the performance in whole or in part by the other party of any obligation under this is prevented or delayed by reasons of war, hostility, acts of public enemy, civic commotion, sabotage, act of state or direction from statutory authority, explosion, epidemic, quarantine restriction, strikes and lock-outs, fire, floods, natural calamities or any act of God (hereinafter referred to as event), provided notice of happenings of any such events is given by the effected party to the other within 7 calendar days from the date of occurrence thereof, neither party shall, by reasons of such events be entitled to terminate the Memorandum of Understanding, nor shall other party have any such claims for damages against the other in respect of such non - performance or delay in performance. Provided service under the MOU shall be resumed as soon as practicable after such event comes to an end or ceases to exist. The decision of BSNL as to whether service may be so resumed (at the time frame within which the service may be resumed) shall be final and conclusive. However, the Force Majeure events noted above will not in anywhere cause extension in the period of the MOU.

i) Dispute resolution and arbitration:

In case of dispute, there shall be an arbitration committee comprising of representative/s nominated by the Board of Management, **SATYA INSTITUTE OF TECHNOLOGY AND MANAGEMENT (SITAM)**, Vizianagaram and representative/s nominated by Head of Visakhapatnam BSNL telecom district, Visakhapatnam. The decision of the arbitration committee shall be binding on both parties.

a. The Memorandum of Understanding shall be subject to exclusive jurisdiction of courts at j) Arbitration Clause:

Except as otherwise provided elsewhere in the contract, in the event of any disputes, controversy, or differences arising out of or relating to this MOU, or the breach, termination or invalidity thereof between the parties, such party or parties shall make a request to the other party or parties to amicably settle such differences or disputes and parties shall thereupon make every effort to settle the same amicably within a period of 60 (sixty) days from the date of making of such request.

Where parties are unable to settle the disputes through concillation, the same shall be referred to the authority in BSNL (GMTD Visakhapatnam) for referral of such disputes to a sole arbitrator (chosen from the name(s) provided by BSNL), to be mutually decided by the parties, as per the provisions of the Arbitration and Conciliation Act, 1996, any amendment thereof, and any notification issued or rules made there under from time to time.

The venue of the arbitration proceeding shall be Visakhapatnam.

The fee will be decided in accordance with the mutual consent and as per the industrial 2. PAYMENT TERMS:

- a) For BSNL-certified courses, internships, and project training, the fees will be paid directly to BSNL by the student.
- b) For On-Campus training fee will be paid directly by the SATYA INSTITUTE OF TECHNOLOGY AND MANAGEMENT (SITAM) to BSNL Visakhapatnam in the form of NEFT to AO (Cash) O/o BSNL Visakhapatnam before ten days.
- c) Amount paid/deposited cannot be refunded under any circumstances.

d) On-campus trainings:

SATYA INSTITUTE OF TECHNOLOGY AND MANAGEMENT (SITAM) will arrange accommodations to conduct training classes on the SATYA INSTITUTE OF TECHNOLOGY



AND MANAGEMENT (SITAM) premises, and Practicals will be conducted on the BSNL INSTITUTE OF TECHNOLOGY AND MANAGEMENT (SITAM) itself, provided the BSNL agrees to conduct classes on the college premises,

A Comprehensive training report (Attendance / Evaluation, etc.) shall be furnished by BSNL TP, Visakhapatnam, to SATYA INSTITUTE OF TECHNOLOGY AND MANAGEMENT (SITAM).

4. Process Methodology

- a. SATYA INSTITUTE OF TECHNOLOGY AND MANAGEMENT (SITAM) may inspect the training programs randomly by authorized persons and binding on BSNL TP, Visakhapatnam, to extend all support to SATYA INSTITUTE OF TECHNOLOGY AND MANAGEMENT (SITAM), Visakhapatnam.
- b. BSNL TP, Visakhapatnam, will rectify any shortcomings observed during the visit on an immediate basis.

A summary of all programs that shall be delivered under this Memorandum of Understanding is as per schedule II.

- 5. The BSNL TP will evaluate the students for the Training Skills and award grades, and such grade sheets will be submitted to the SATYA INSTITUTE OF TECHNOLOGY AND MANAGEMENT (SITAM).
- 6. The BSNL TP shall maintain a record of the registered students and certificates issued and upload the same on the BSNL web portal.
- 7. No Confidentiality: There shall not be any confidentiality of any information disclosed by either party to each other, either in operationalizing this Memorandum of Understanding or for the purposes of implementing this Memorandum of Understanding. The information sought under the Right to Information Act or otherwise by any student shall be promptly made available.

8. The BSNL agrees and undertakes that the BSNL - TP as recognized and approved by SATYA INSTITUTE OF TECHNOLOGY AND MANAGEMENT (SITAM), shall act as a Training Provider in terms of the Memorandum of Understanding signed by them with the SATYA INSTITUTE OF TECHNOLOGY AND MANAGEMENT (SITAM) and the Memorandum of Understanding to be signed between the SATYA INSTITUTE OF

- 9. The BSNL shall participate, operate, and execute the scheme strictly in accordance with the scheme in GENERAL for Technical Courses initiated by the SATYA INSTITUTE OF TECHNOLOGY AND MANAGEMENT (SITAM) and shall not indulge in any violation of the scheme.
- 10. Both the parties shall indemnify and keep the other party indemnified and harmless against any and all claims, actions, and proceedings by a third party (including all costs, expenses, damages/losses) arising out of or in connection with this MOU due to breach of any provisions of this MOU by such party or as a result of any act of negligence/omission or commission on part of such party and/or its employees, agents etc.
- 11. The present Memorandum of Understanding can be terminated by the SATYA INSTITUTE OF TECHNOLOGY AND MANAGEMENT (SITAM) /BSNL by giving a notice of one month to BSNL/SATYA INSTITUTE OF TECHNOLOGY AND MANAGEMENT (SITAM) without assigning any reason in this regard and the SATYA INSTITUTE OF TECHNOLOGY AND MANAGEMENT (SITAM) /BSNL shall have no claim against each and its officials on account of termination of such Memorandum of Understanding. However, the responsibilities and duties of both parties in respect of the common students already registered shall not end with the termination of the Memorandum of Understanding, and these will remain valid in totality until the completion of the evaluation of the already registered students and reporting of their results by both parties.

12. Effective Date:

This Memorandum of Understanding is effective from the date signed by both parties and will be valid for a period of **FIVE** years until determined, suspended, or terminated earlier.

13. The BSNL Visakhapatnam Training point is already registered in the **AICTE** portal with Corporate Reference ID: CORPORATE 611b7197719441629188503.

4. Space & Basic Infrastructure

BSNL will provide limited space, facilities, and basic infrastructure in support of this initiative at the BSNL campus; BSNL shall extend its

The provisions of this Article will not apply to any information in the public domain; information in the possession of the receiving Party prior to the disclosure of the information; information which is independently developed by the receiving Party; Information required to be released by law; and information which is rightfully received by receiving Party from third parties without any breach of confidentiality obligations. Also, real-time monitoring of the water distribution up to the delivery point using individual

Latest smart Applications:

a) RF ID in Medical Applications:

Medical Information systems are expected to be useful for both logistical and medical personnel. As such, the systems are reliant upon the sensors implemented to acquire information for both groups. Such sensors may be divided by their competency in environment sensing or object identification. Typically, environment sensors are limited by their per-unit price, reducing their scalability. Similarly, current object identification systems involve barcodes limited by line-of-sight (LOS). Radio-frequency identification (RFID) proposes a reasonable solution to both problems through comprehensive and cheap tag designs. Such designs allow real-time monitoring of medical equipment, patient medical adherence, and new means of disease diagnosis in patients. Consequently, RFID may be viewed as an avenue for improving both medical equipment logistics and diagnostic options.

b)Boom Barrier:

A Boom Barrier is a Bar or Pole placed at a pivot to move up and down to control vehicle access in a particular premises. It is used for both Commercial and Residential purposes. The Operation of an Automatic Security Gate or Boom Barrier varies in Size, Shape and Operation. If you want to protect your Home or Business, a Boom Barrier is an added Security. It ensures that you are in control of vehicle movement within your premises. There are several versions of Boom Barriers, such as Hydraulic, Electromechanical and Manual boom barriers. One of the distinguishing features is their simplicity of assembly.

Robotics:

Robotics today is undergoing a transformation with robots increasingly stepping out of their factory cages. At the robotics lab we specialize in the mechanical design and algorithmic control of physical interaction between the robot and its environment at O, A & B levels. All the branches of the students can enroll and learn all the levels and obtain certificates for each levels and
